## COLUMBUS BLUE JACKETS, KROGER, and CBJ GAMING NHL24 "CBJ Gaming Kroger 6v6 Finale" (Crossplay) Official Rules

**ELIGIBILITY:** Participation in the Columbus Blue Jackets NHL24 "CBJ Gaming Kroger 6v6 Finale" (Crossplay) (the "Tournament") is available only to eligible Entrant and Participants as provided herein.
